CHAPTER-1

Introduction, Methodology and Distribution of Respondents

Introduction:

Especially to promote awareness, to understand the level of gender equality in higher educational institutions and also to find out probable solution to minimize gender discrimination, it is vital to execute gender audit by applying different scientific methods.

Ever since its establishment the college has fulfilled the needs of Higher Education for the people of Baghmundi Block and the adjoining areas. The college is a co-educational institution situated in Suisa village, District Purulia of West Bengal. Students' engagements in extracurricular activities like NSS, Sports and Culture are encouraged under the guidance of faculties of the college. The college always contemplates on students' qualitative performances along with their overall personality development. The NSS unit of the college is ready to motivate the students towards social responsibilities all the time. Although the college has been offering all such facilities for overall development of the students, yet it is important to find out any gender gap that may exist in the college and initiate appropriate measures to mitigate it.

OBJECTIVES:

- 1. To understand the level of gender equality in the college.
- 2. To find out the areas where gender inequality exists in the college.
- 3. To suggest appropriate measures for reducing gender gap.

Methodology:

As part of the Audit survey method has been used by using questionnaire in class time. To collect primary data on Gender related aspects, questionnaire is designed for the girl students of the college. Out of 270 number of respondents, 35% girls have been selected through simple random sampling method. The total sample size of the study is 96 number of girl students. The questions in the study have been given with a five point rating scale as strongly agree, agree, neutral, disagree and strongly disagree.

Indicators: The following gender sensitive indicators have been used to evaluate:

- a. Organization and management.
- b. Infrastructure.
- c. Students' participation and involvement.
- d. Existence of women cell and internal complaint Committee.

Distribution of the Respondents

The survey has been done covering students of all the semesters and departments of the college. The total number of 88 girl students are the respondents of this survey. The following two diagram shows semester and department wise distribution of the respondents




Figure No-01: Distribution of Respondents.



Organisation and Management


(i)The College follows gender equality in every sphere




Figure No- 4: The College is free from sexual harassment




Figure No-5: Proper and timely action on complaints




Figure No-6: The College provides health care facilities




Figure N o-7 Safety for students inside & outside of the campus




Figure No: 8 Options for flexible timing





Figure 9: Classroom offers equal opportunities for all gender

From the above diagram it is come to know that more than 90% girls agree and strongly agree with the statement Classroom offers equal opportunities for all gender.








Figure No 10 : Toilets for Girls




Figure No 11: Cleanliness is maintained in boys' and girls' toilets




Figure No- 12: Adequate electrification facilities, corridors and girls' common room.





Figure No-13: Equal library facilities for all genders




Figure No-Women Faculty accompanies the girl students




Figure16: Sports facilities




Figure 17: Equal opportunity in and outside the college campus




Table 18: All genders can express their views, ideas




Figure No-19: Gender awareness programme




Figure 20: : Equal right of representation in Student Union and other Committees

Figure 5.0: Woman Celland students areawareness




Figure 21:Woman Cell and students awareness




Figure 22: Women Cell comes forward to tackle any awkward situation




Figure22: The Internal Complaint Committee

Chapter:3

Recommendation
